Cleaning Machine for sewage pipes with DN from 50 to 150 mm - 1 set.

Tenders are invited for one or more lots. Each lot must be priced separately. Tenders for more than one lot may offer discounts and such discounts will be considered in the comparison of tenders.

Tendering for contracts that are to be financed with the proceeds of a loan and a grant from the Bank is open to firms from any country.

To be qualified for the award of a contract, tenderers must satisfy the following minimum criteria:

Experience as supplier in at least 2 contracts within the last 5 years, each with a value of at least 20,000 Euros for Lot 1 and 10,000 Euros for Lot 2[1]. In case of participation in both Lot 1 and Lot 2 the threshold is calculated cumulatively. Only those contracts will be taken into account which have been

successfully and substantially completed and that are similar to the proposed Goods. The similarity shall be based on the financial value and level of complexity as described in Section VI, Supply Requirements. In addition the local tenderers shall submit the information about the lack of outstanding tax and social fund payments.
