  - I. Local Developers / Contractors who registered with Construction Industry Development Authority (CIDA) and having level C1 or above

project. In these circumstances, developer / investor should be required to undertake the construction as a joint venture with a local contractor who registered with Construction Industry Development Authority (CIDA) and having level C1 or above.

 Average annual value of Turnover of construction work performed in the last 5 years shall be at least LKR 1.0 Billion.

- Minimum of 50% Initial Contract Price shall be financed by the bidder and the total contract sum will be paid by the UDA after completion of the Project.
