Shipping Guidelines

Welcome to China-CEEC Expo & International Consumer Goods Fair 2023. The Organizer has designated logistics service provider to offer services for clearance, storage and on-site exhibition-related services.

To ensure a successful exhibition, the exhibitors should arrange their shipments according to the provisions in this Shipping Guidelines, submit necessary documents through the exhibitor's online system for preview before the shipment of the exhibits.

Exhibits Requirements

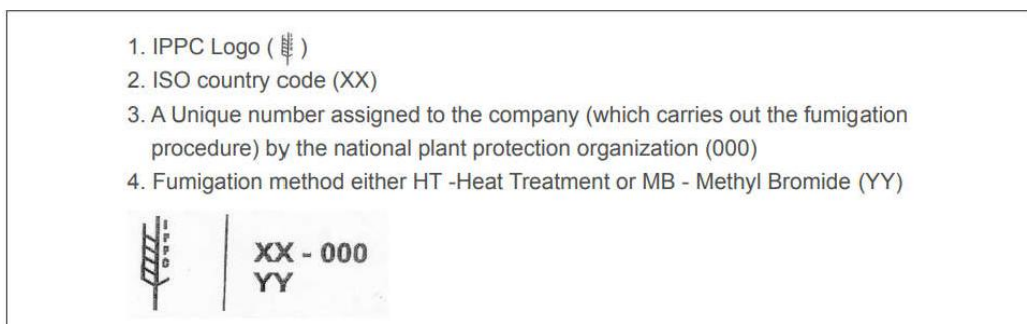
For exhibits that meet the relevant regulations, including *List of Plants and Animals as well as Their Products and Special Goods to be Approved of Entry (annex 1)*, *Inspection and Quarantine Restriction List (annex 2)*, *Prohibition List of Inspection and Quarantine (annex 3)*, China Customs allows the exhibits to enter into China on the basis of “temporary imports and exports”.

Reminders

1. About Tariff, VAT and other relevant taxes. It is regulated by Chinese law that all the goods imported under the terms of regular trade should be levied tariff, VAT and other relevant taxes.



2. The goods to be sold during the exhibition shall be completed with all the customs clearance procedures and taxed. The relevant import permit should be applied in advance.
3. Transportation terms: CIF Ningbo (the only acceptable term)
After the goods arrive at Ningbo port, in-land transportation, logistics and storage fees will be borne by organizing committee.
4. In the event of late arrival (after April 16, 2023), the service provider will make all reasonable endeavors to ensure delivery to the booth before the commencement of the Expo, without making any commitment.
5. After the preview of required documents is completed, the consignee info will be delivered to exhibitors.
6. Some samples will be taken and used for quarantine and examination by China Customs.
7. Chinese Regulations on Wooden Packaging :
 - I. The Chinese government requires that all the goods entering China with wooden packaging (i.e. wooden materials used to carry, pack, lay, support and reinforce goods, such as wooden cases, crates, pallets, frames, barrels, wooden shafts, wedges, chocks, sleepers and crossers.), must be handled by those enterprises accredited by the plant inspection and quarantine authorities in the countries or regions of origin pursuant to the inspection and processing method confirmed by China.
 - II. To ensure that all the goods entering China has been fumigated via heat treatment (HT) or methyl bromide (MB), all the wooden packages must be marked with an IPPC logo as below that has been approved by the competent plant inspection and quarantine authorities:



For smooth customs clearance, exhibitors are advised to prepare a fumigation declaration (**annex 5**) printed on a paper with their company letterhead. Such declaration shall be attached to the original master air waybill (for air freight), or enclosed with the original bill of lading (for sea freight), or couriered to the official forwarders. All entering goods with wooden packages without acceptable fumigation logos or in no compliance with above requirements will either be destroyed right on the spot by the Chinese customs, or not be cleared and returned by force. As for entering goods with



non-wooden packages, the consignor shall prepare a valid letter of certification or declaration (**annex 4**) stamped with the corporate seal of the goods owner, and couriered to the official forwarders together with the original air waybill (for air freight) or bill of lading (for sea freight).

Annex 1.

Plants and Animals as well as Their Products and Special Goods to be Approved of Entry

1. Animals and Animal Products

- a. Live animal and live embryo, seminal fluid, germ cell, hatching egg and other animal genetic materials;
- b. Imported animal serum products, vaccine and biological products;
- c. Edible animal products: meat and meat products (including viscera, casing), fresh egg (including edible fresh tortoiseegg, edible turtle egg), dairy products (including raw milk, raw dairy products, pasteurized milk, the modified milk produced from pasteurized sterilizing techniques), aquatic products (including batrachians, reptiles, aquatic mammal and other breed aquatic products and uncooked processed products, Japanese aquatic products etc.), and animal-derived foods such as edible bone, hoof, and horn and products, animal-derived traditional Chinese medicinal materials, and cubilose etc.
- d. Non-edible animal products: raw skin, original skin hairs, bone, hoof, and horn and products, silkworm cocoon, fish meal, meat meal, bone meal, meat and bone meal, grease, dried blood and blood etc, the organic fertilizer containing animal derived ingredients.
- e. Feed products: compound feed, chilled and frozen animal products for feed (including for bait), aquatic products for feed (including for bait), processed animal proteins and oils and fats, pet food and bites (except tinned).

2. Plants and plant products

- a. Seed, nursery stock and propagating materials;
- b. Garden stuff: fresh fruit, solanaceae and vegetables;
- c. Grains: wheat, corn, rice, barley, rye, oat, sorghum and other coarse cereals etc;
- d. Beans: soybean, mung bean, peas, phaseolus anagularis, broad bean, chickpea and other mixed beans etc;



- e. Potato: potato, cassava, sweet potato and other processed products;
- f. Fodder: wheat bran, bean cake and bean pulp etc;
- g. Cigarettes and tobacco: tobacco and tobacco sheet.
- h. Plant-derived traditional Chinese medicinal materials.
- i. The plant-derived foods with the outbreak risk of epidemic disease.

3. Genetically Modified Animals and Plants

Whether “Genetically Modified” or not should be stated to the animal and plant products which are involved to genetically modified marking contents; if the product contains genetically modified ingredients, it shall be provided along with the “GMF Bio-safety Certificate” issued by Ministry of Agriculture.

4. Special Goods

Inbound microorganism (virus, germ, fungus, actionmycetes, Rickettsia, spirochete, Chlamydia, mycoplasma etc medical microorganism (virus) as well as specimen and parasite, environment protective microbial agent), human tissue (human body cell, cell line, embryo, apparatus, tissue, bone marrow, secreta and excreta etc), biological product (used for physianthropy, bioscience related vaccine, antitoxin, diagnose reagent, cell factor, enzyme and preparations as well as toxin, antigen, allergen, antibody, antigen-antibody compound, nucleic acid, immunomodulator, microecologics etc biological activity preparation), blood and its products (human whole blood, plasma components and special blood constituent, various human plasma proteins products) etc should be approved along with the *Approval Form for Entry/Exit Health Quarantine on Special Goods* as issued. They shall pass the inspection and quarantine and be qualified before entering and shall accept the supervision by the country.
